Technical agreements with regard to the performance SONO IO? concerning get-in, set-up, safety standards, entry of the audience etc. must be made in advance.

2 To be provided by the organiser

2.1 Location

- Theatre or alternative accommodation suited to stage shows.
- 'Sono io?' is a non-verbal performance, so visibility and contact with the audience is very important.

Therefore our preference is for a **level floor** or **with the audience on stage**. A stage is also an option, provided there is good visibility and a limited distance between the performers and the audience.

- The performance area must have a minimum of the following dimensions: preferably 8 m wide by 9 m deep (minimum 7 m wide by 8 m deep)
- For performances with the audience on stage, the performance area must measure a minimum of 19 m wide and 14 m deep.
- The **unimpeded height** above the performance area must be **5 m**. (the absolute minimum).
- The organiser must provide a **mounting point** in the ceiling that will bear a minimum load of **400 kg** (for a person/aerial acrobatics) in the middle of the performance area at a distance of 3 to 4 m from the edge (see floorplan). If in doubt, please call the company.
- The space must be completely blacked out.
- 2 dressing rooms with toilet and shower with hot water are required.
- For technical and aesthetic reasons, we ask you to send us a number of photos/plans.

Attached you will find our lighting plan/floorplan of the performance area. You will also find a photo of the scenography and a list with the required lighting material.

2.2 Stage hands

The organiser must provide a minimum of 2 people upon **arrival** of the company (at +/-11h00) to help unload the trucks.

During the get-in: minimum of 1 lighting technician, with a knowledge of the technical capacities of the relevant auditorium. This person must remain in attendance during the show. The company will also bring one lighting technician.

Get-out: a minimum of 2 people to help load the truck.

2.3 Permits

The organiser must be in possession of the necessary approved contracts and permits from the council authorities, police and fire service. If any contracts or permits are missing the organiser cannot plead force majeure.

2.4 Parking

Parking for 1 truck and 2 cars, as close as possible to the backstage entrance.

3 Miscellaneous

3.1 **Secondary activities**

If **secondary activities** are linked to this performance (or these performances), they must in no way hinder the artistic work of the circus company. In addition, any such activities must always be discussed with the circus management. If, through these activities, the organiser creates disturbing noise outside the auditorium during the circus performance, the circus management has the right to bring the performance to an early close.

SONO IO? is an **evening performance** and the earliest possible programming time is **from 8 pm**.

The performance is suitable for adults and children aged 12 and above.

3.2 Advertising

Under no circumstances may the organiser place sponsor advertising on the stage or in the auditorium, for obvious aesthetic reasons.

3.3 Changes to the performance

Under no circumstances may the organiser make changes to the performance or duration.

3.4 Low emission zones

If the event is taking place in a low emission zone, the organiser must provide the necessary permits, and the costs of these must be borne by the organiser.

3.5 <u>Liability</u>

If the organiser fails to comply with one of the aforementioned conditions, Circus Ronaldo/vzw Circus Van Vlaanderen cannot be held responsible for any material or physical damage.

The circus management cannot be held responsible for any damage caused by third parties (e.g. the audience) to the theatre or its infrastructure.
